

## 2023-2023 Application

Application Deadline: March 15, 2023

#### Overview:

The *Jackson T. Stephens Scholarship* awards participants who excel in academics, leadership, character development, and chapter and community involvement. Thanks to the generous donors of our 20<sup>th</sup> Anniversary Celeberation, First Tee-Central Arkansas is proud to offer a \$5,000 scholarship provided to one young woman and one young man to help with cost of their college education.

#### **Participant Selection:**

Applications are accepted once per year from seniors in high school who meet the minimum eligibility requirements. All components of the application will be reviewed with consideration that this scholarship is a need and merit-based scholarship.

Following the closing date of March 15, 2023, a judging committee will review the submissions and identify one youngman and one young woman to receive a one-time \$5,000 *Jackson T. Stephens Scholarship*. The selections will be announced by April 30, 2023. Applications are accepted once per year from seniors in high school who meet the minimum eligibility requirements. All components of the application will be reviewed with consideration that this scholarship is a need and merit-based scholarship.

#### **Eligibility Requirements:**

To be eligible for the Jackson T. Stephens Scholarship, applicants must meet ALL the following requirements:

- Must be enrolled as a high school senior as of December 31, 2023
- Minimum 2.75 high school GPA on a 4.0 grading scale
- Intends to attend a four-year accredited college or university in Fall 2023
- Involved in First Tee Central Arkansas activities at the time of application submission
   o Participants who have spent a longer time in First Tee programs
   will receive higher consideration in the selection.
- Evidence of meaningful involvement in community and civic activities

## **Jackson T. Stephens Overview:**

Jackson T. Stephens built an extraordinary legacy. Coming from humble beginnings on a farm near Prattsville, Arkansas, his parents – and the hard times of the Great Depression – taught him the values of self-reliance, diligence, integrity and hard work. His father, A.J. Stephens, once told his young son, "Success is not a destiny to be reached, but the quality of the journey we make."

The advice from his father stayed with him throughout his life. Jack graduated high school from Columbia Military Academy in Tennessee. He attended the University of Arkansas in Fayetteville and graduated from the United States Naval Academy in 1946. (Class of '47).

Upon his graduation from the U.S. Naval Academy, Jack came to Little Rock and joined his brother Witt Stephens in the municipal bond business. The two formed the firm, Stephens Inc., on a handshake partnership that lasted more than 40 years, until Witt's death in 1991. Witt was a gregarious and shrewd businessman and a great salesman. Jack was quiet, thoughtful, and equally astute. While Witt ventured into politics and running the local gas utility, Jack began to expand the investment business into the sales, trading and underwriting of corporate securities. He also expanded the practice of making direct investments in private companies for the firm's account, predating by decades the private equity endeavors of Wall Street firms.

Jack served as President and CEO of Stephens from 1957 to 1986. The expansion of the firm's activities under Jack's leadership in the 1950s and 1960s led to Stephens becoming the largest investment banking firm in the country (measured by capital) located off Wall Street, and one of the top ten firms overall, along with the likes of Merrill Lynch, Morgan Stanley, and Goldman Sachs. Jack was instrumental in providing capital and investment banking services to an array of Arkansas companies that became large and successful enterprises, such as Wal-Mart Stores, Tyson Foods, J.B. Hunt Trucking, Alltel Corporation. He also invested in community banks across the state, culminating in the purchase of Little Rock's Worthen Bank, ultimately sold to what is now Bank of America. His son, Warren, assumed the role of President and CEO in 1986, and continues to build on these efforts today, while also serving as Chairman.

Jack's private investments were spectacularly successful, and it is often noted that he was one of the finest investors of the 20<sup>th</sup> century. His acumen as an investor was combined in remarkable fashion with his ability to form enduring personal relationships with his partners. Several generations of companies and business leaders came to know Jack as not only a smart investment banker but as a loyal and reliable friend. His opinions were constantly sought by investors, CEOs, and politicians and his influence grew to the boardrooms of corporate America and to the halls of Washington D.C.

Jack received numerous recognitions. In addition to serving on several local boards, he was appointed to a ten-year term on the University Of Arkansas Board Of Trustees, in 1948. During his tenure, the University of Arkansas Medical School and the University of Arkansas School of Law were integrated, making those institutions among the first in the South to take, what was then considered, a bold decision regarding admissions.

Jack received a Distinguished Alumnus Citation in 1965. He was awarded an honorary Doctor of Law Degree from the University of Arkansas in 1985. In 1989, he was the first recipient of the annual J. William Fulbright Award given for international trade development. He also received Horatio Alger Award in 1980, becoming a lifetime member of this Association of Distinguished Americans.



Today, there are ample reminders of his lifelong philanthropy and generosity. The University of Arkansas in Fayetteville, in Little Rock, and at the Medical School; Harding University; the Arkansas Arts Center (now the Arkansas Fine Arts Museum); and at numerous public and private schools, to name a few.

Jack's love of sports led to a \$10 million gift to the U.S. Naval Academy Foundation in Annapolis, Maryland. The donation funded the renovation at the Navy Marine Corp Stadium near the campus, which has been renamed Jack Stephens Field. The gift is the largest ever made to the Naval Academy.

When asked by the PGA TOUR if he would support the launching of a new program to teach golf and its values to children by creating affordable and accessible golf facilities, Jack surpassed their expectations with a \$5 million donation to help start The First Tee. He said, "Golf is a great teacher in life. The same skills needed to master this game are the same skills needed to master life, a life full of unseen obstacles and excitement."

In 1962, Jack was invited to become a member of the Augusta National Golf Club. In 1991, Jack's trustworthiness and love of the game led him to be selected as the fourth Chairman of Augusta National Golf Club, with the responsibility of overseeing the golf club and the most prestigious tournament in golf, the Masters. Upon retiring as Chairman in 1998, Jack Stephens was named Chairman Emeritus of the club.

The ongoing business activities and reputation of Stephens are largely the result of Jack Stephens' personal attributes: thoughtfulness, quietness, graciousness, and reliability.




